A Petition for Annexation has been filed with Ephraim City proposing the annexation of an area to Ephraim City known as the "West Christensen Annexation 2022." 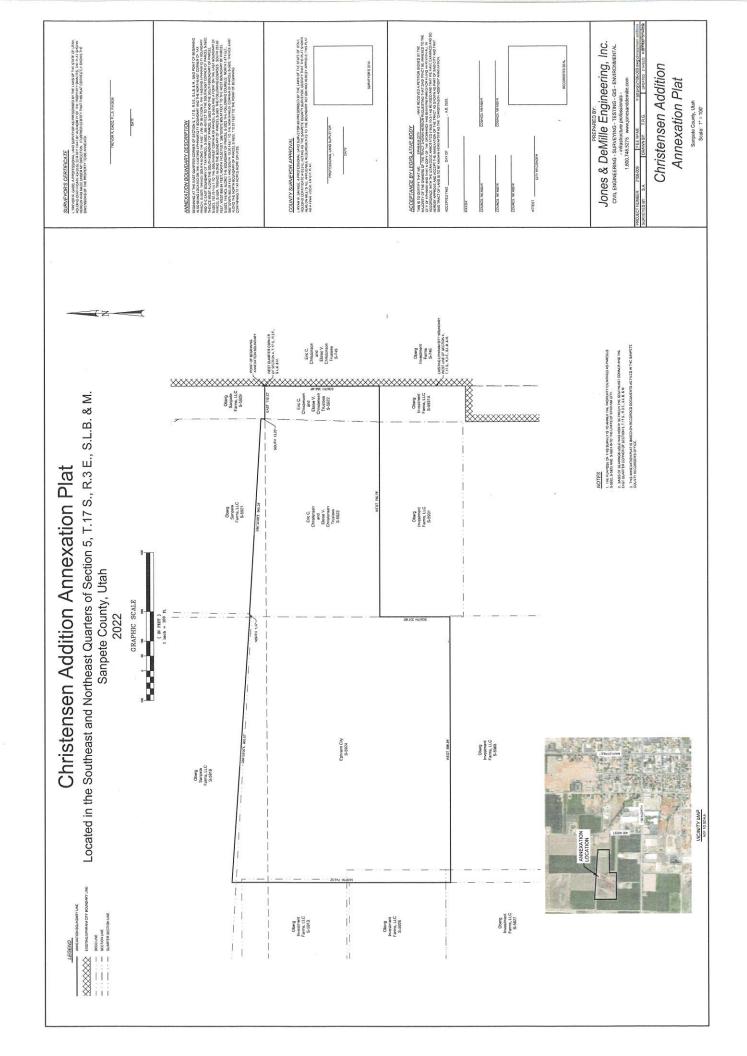
